Dear Ladies and Gentlemen,

With this letter we inform you that our products are conform to the REACH regulation (EC) 1907/2006. We also comply with the "Regulation (EU) 2018/1881 of December 3rd, 2018 amending Annexes I, III, VII, VIII, IX, X, XI, XII, and (EC) 2022/586 of April 08th, 2022 amending Annexes XIV of Regulation (EC) 1907/2006 of the European Parliament and of the Council on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) with a view to the nano forming of substances.

The EU suppliers of products which are processed into our products in a relevant degree are also obliged to inform us unsolicited, if the products they supply, contain a SVHC substance above 0,1%. If we receive information from our suppliers and learn that our products exceed the 0,1 mass percentage threshold for a SVHC substance, we will inform you immediately.

We ask our EU suppliers to comply with their obligations to inform us voluntarily and without delay if a delivered product contains a substance of very high concern (SVHC) in a mass concentration above 0,1%. The relevant information is then contained on our delivery note.

With all non-EU suppliers, we make separate arrangements, as they are not automatically subject to the REACH information requirements. Non-EU suppliers have to inform us in writing if the delivered product contains a substance of very high concern (SVHC) in a mass concentration above 0,1 %. The relevant information is then contained on our delivery note.
